ORDER

For good cause shown, the Plaintiff’s MOTION FOR THE COURT TO DIRECT THE CLAIMS ADMINISTRATOR TO TRANSMIT ITS PRELIMINARY APPROVAL/ REJECTION LETTERS TO THE CLAIMANTS filed by Plaintiff CITY OF BIRMINGHAM RETIREMENT AND RELIEF SYSTEM is GRANTED and the following is ORDERED:

1. The claims administrator, Gilardi and Co., LLC is ORDERED and DIRECTED to mail or transmit letters to each claimant stating that their claim is recommended by the claims administrator either to be rejected (and on what ground) or to be approved (and in what amount).
2. The letters must explain that the claimants have 28 days from the date of the letter to request further review by Gilardi if they believe the recommended disposition of their claim is in error.
3. The claims administrator shall review every such request for review and make a recommendation on each as soon as practicable.
4. When Gilardi has processed all such requests, Gilardi must file with the Court its final recommendations and the Court will then set a hearing, if the Court determines a hearing is necessary, on the request for final Court approval for the disposition of claims.

5. Class Counsel are DIRECTED to transmit a notice styled “Notice of Right to File Additional Materials or Written Arguments” to the three groups of claimants identified in the motion as being claims for which Gilardi has no recommended disposition. The content of the Notice shall be substantially as presented in the motion.
