**FINAL ORDER ON PAYMENT OF CLAIMS**

This matter came before the Court on PLAINTIFF’S MOTION FOR THE COURT TO APPROVE THE CLAIMS ADMINISTRATOR’S FINAL RECOMMENDATIONS FOR THE PAYMENT OF CLAIMS (Doc 3782, 12/3/2018). Exhibit 1 to this MOTION is the November 30, 2018, Declaration of Marc Wall, representative of Gilardi & Co. LLC, the claims administrator for this class-action settlement. Wall’s November 2018 Declaration includes Exhibits A-1, A-2, and A-3, which list a recommended disposition for each of the 9535 claims that were filed in this settlement process. After examining the filings and after hearing from Class Counsel, the Court hereby GRANTS this motion.

WHEREFORE, IT IS HEREBY ORDERED, as follows:

1. The claims listed in Exhibits A-2 and A-3 to Exhibit 1 of Doc 3782 are rejected.
2. The claims listed in Exhibit A-1 to Exhibit 1 of Doc 3782 are approved, and in the amounts shown on A-1 for the claimants’ recognized losses and for the figures shown for the amounts received, if any, from the 1999 settlement.
3. The claims administrator (Gilardi) is directed to promptly begin to process and transmit payments to the approved claimants listed on Exhibit A-1.

4. In calculating the payments, the claims administrator must apply the Plan of Allocation (which was reproduced in the 2016 long-form NOTICE OF PROPOSED SETTLEMENT OF CLASS ACTION).

5. The claims administrator is ORDERED and DIRECTED to process payments to Authorized Claimants pursuant to the plans detailed in ¶¶ 11-16 and 21 of Wall's Declaration of November 30, 2018 (Doc 3782).

6. The Court specifically approves of each claims-administration process set out in ¶¶ 11-16 and 21 and adopts and incorporates by reference as a part of this Order the recommendations in Exhibit A-1, A-2 and A-3 and the claims administration process set out in ¶¶ 11-16 and 21 of Wall's Declaration of November 30, 2018 (Doc 3782).
